Therapeutic Touch	Physical contact to provide comfort and support.
Active Listening	Fully concentrating on what is being said.
Duty to Warn	Notify potential victims of credible threats from clients.
Restraints	Last resort for safety; requires monitoring and documentation.
Seclusion	Isolation used to ensure immediate safety of clients.
Psychiatric Advance Directives (PADs)	Client preferences for future mental health treatment.

Cultural Competence	Respecting cultural beliefs impacting treatment choices.
Mental Health Parity Act	Equal insurance coverage for mental health and physical health.
HIPAA	Protects patient privacy and confidentiality of records.
Tarasoff Ruling	Allows breach of confidentiality for serious threats.
Americans with Disabilities Act (ADA)	Prevents discrimination against individuals with mental disorders.
Patient Self-Determination Act (PSDA)	Clients can make advance directives for treatment.
Involuntary Commitment	Legal process for treating clients posing danger to self.
Emergency Commitment	Temporary hold for crisis stabilization, usually 48-72 hours.
Civil Commitment	Court-mandated long-term treatment with judicial review.
Informed Consent	Clients can refuse treatment unless legally incompetent.
Legal Guardian	Makes decisions for clients deemed incompetent by court.
Continuous Monitoring	Required during use of restraints or seclusion.
Least Restrictive Measures	Attempt verbal de-escalation before restraints or seclusion.
Rights of Psychiatric Patients	Humane treatment and freedom from abuse guaranteed.
Access to Records	Patients can request corrections to personal records.
Refusal of Medication	Patients can refuse unless in emergencies or court- ordered.

Mandated Reporting Laws	Report abuse cases despite client confidentiality requests.
Advocacy	Nurses advocate for client rights and safety.
Documentation	Thorough records required for restraints and involuntary commitment.
Client Education	Inform clients of their legal rights regarding treatment.
CMS Standards	Regulates use of restraints for immediate physical safety.
Behavioral Safety	Restraints must end when safe behavior is restored.
Legal Implications	Understanding laws essential for ethical mental health care.
Joint Commission Regulations	Guidelines for safe use of restraints and seclusion.
Physician Order	Required for restraint application and renewal.
Restraint Renewal Frequency	Adults: every 4 hours; adolescents: every 2 hours; children: every 1 hour.
Continuous Monitoring	Necessary during seclusion and physical restraints.
TJC Standards	Guidelines for safe restraint and seclusion practices.
Prohibition of Punishment	Restraints must not be used for punishment or convenience.
Least Restrictive Method	Attempt verbal de-escalation before restraints.
Face-to-Face Evaluation	Provider evaluation required within 1 hour of restraint.
Annual Staff Training	Mandatory training on safe restraint use.
Trauma-Informed Care	APNA advocates minimizing restraint use.
Crisis Prevention Strategies	Encourages early intervention to prevent crises.
Debriefing Importance	Essential after incidents for learning and improvement.
